**Subject: Constable (Driver) Male in Delhi Police Examination, 2025 – Declaration of result of Computer Based Examination for shortlisting candidates to appear in Physical Endurance & Measurement Test (PE&MT)/ Document Verification (DV)/ Trade Test – reg.**

The Staff Selection Commission conducted a Computer Based Examination for the recruitment of Constable (Driver) male in Delhi Police on 16.12.2025 and 17.12.2025 at various centres across the country.

2. Computer Based Examination of the said examination was conducted in multiple shifts, hence, marks scored by candidates have been normalized as per the formula published by the Commission vide Notice dated 02,06.2025. As per the provisions under Para 11.3 of the Examination Notice, normalized marks of the candidates have been used for processing the result to shortlist the candidates for the next stage of examination [Physical Endurance & Measurement Test (PE&MT)/ Document Verification (DV)/ Trade Test].

3. In terms of Para-15.4 of the Notice of Examination, minimum qualifying marks in the Computer Based Examination (without adding bonus marks to NCC certificate holders) have been fixed as follows:

- a. Unreserved/EWS : 40
- b. SC/ST/OBC : 35
- c. ESM : 30

4. Based on the cut-off fixed by the Commission in CBE, the number of candidates qualifying for appearing in PE&MT/ DV/ Trade Test is as follows:
